Criterion Personnel was rated Good. Feedback: The qualifications of the principal/key investigators, supporting staff, and consultants were good. The qualifications indicated that the team could perform the research and development, and also demonstrated a good ability to commercialize the results.

Criterion Commercialization was rated Acceptable. Feedback: The potential for commercial (Government or private sector) application and the benefits expected to accrue from this commercialization are acceptable.
